The samples of dry turmeric fingers and bulbs separately will be received by the committee on 27.05.2014 up to 1:00 PM in the office of the Manager, Hafed Turmeric Plant, Radaur. Samples of dry turmeric fingers / bulbs will be sent for analysis to Agmark lab / Pvt. Lab. After the analysis result received in the Plant, farmer will be informed about the rates as per quality of turmeric stocks. Terms & Conditions of Tender for purchase of unpolished dry turmeric fingers / bulbs:

- 1. The quantity of sample should be at least 1 kg.
- Minimum quantity for tender is 3 qtls. If the required quantity is not available from L-1 then the purchase committee can get the balanced quantity from other farmers who wish to supply at L-1 rates.
- The weighment of material shall be carried out at Hafed weighbridge Radaur. In case if Hafed weighbridge is out of order then the weighment of stocks shall be carried out at private weighbridge nearest to plant i.e. Happy weighbridge Radaur.
- 4. While unloading of stocks from Trolly etc. if any quality difference is found in comparison with the sample offered, the purchase of the same lot will be cancelled by the Manager, Hafed Turmeric Plant, Radaur .
- 5. Stocks will be supplied at Hafed Turmeric Plant, Radaur within 3 days of the acceptance of tender or at the requirement of Manager Hafed Turmeric Plant Radaur, failing which the deal will be treated as cancelled.
- 6. Payment of the purchased stocks will be made only through account payee cheque within 3 days of receipt of material.
- 7. Hafed reserves the right to reject the tenders without assigning any reason.
- 8. Conditional tender will not be accepted.
- 9. Hafed may increase / decrease the quantity of stocks to be purchased at the time of tender.
- 10. In case of any dispute raised between Manager, Hafed Turmeric Plant, Radaur and the tenderer, Managing Director, Hafed or his nominee will be the sole Arbitrator and his decision will be final binding on both the parties.
