NOTE: 1. The agency should have executed at least one work of 80% amount OR two works of 50% amount OR three works of 40% amount of similar nature.

Deptt/Board/Corporation for the above mentioned works, in sealed envelope as per the schedule given above from the office of the undersigned and the same will be opened as per the schedule given above respectively in the office of undersigned in the presence of intending contractors or their authorized representatives, who may choose to attend for the purpose.

If the earnest money draft is not found proper as per requirement of the Department, the technical bid and financial bid will not be opened. Also if the contractor didn't qualify the technical bid, the price bid of the same will not be opened.

- 2. Conditional tenders will not be entertained and are liable to be rejected.

- 4. The amount of earnest money shall be same in case of cooperative labour & construction societies as well as other contractors.
