- 1) The rate offered will be on " **AS IS WHERE IS**" basis . The parties will make their own arrangements for dismantling and lifting of the old Par Boiling Unit of Hafed Rice Sheller, Ratia District, Fatehabad.
- 2) The prospective buyers may inspect the old Par Boiling Unit during any working day from 9:00 AM to 5:00 PM in Hafed Rice Sheller, Ratia
- 3) All the participants will have to deposit Rs. 1,00,000/- (Rs. One lac. Only) as Earnest Money for old Par Boiling Unit of Hafed Rice Sheller, Ratia District, Fatehabad before the start of the bid/auction. The successful bidder will have to deposit 20% value of the total cost offered within 24 hours from the acceptance of the offer. The earnest money of the successful bidder will be adjusted in the total cost.
- The successful bidder will have to lift the entire old Par Boiling Unit 4) him/them within 30 days (Thirty) from the date of purchased bν (excluding the date of acceptance of the offer) against full acceptance payment. In case the party fails to lift the old Par Boiling Unit by him within stipulated period, the party is liable to pay carry-over charges @ 18% p.a for the value of unlifted part of the old Par Boiling Unit for delayed period. The maximum time limit with carry-over charges will be 30 days. If the buyer fails to lift the entire old Par Boiling Unit purchased by him within 30+30 days, then the entire money deposited by him will be forfeited without any notice and Hafed will be free to dispose-off the Par Boiling Unit in any manner suitable to Hafed. Hafed reserves the right to extend or not to extend the lifting period.
- 5) The buyers will be at liberty to take delivery of the old Par Boiling Unit purchased through his authorised reperesntative for which he must have the authority letter, which shall be presented to the officer concerned. Such delivery shall be at the purchase's own risk and cost and no claim shall be admissible against Hafed on any account whatsoever, if the delivery is affected to a wrong person.
- 6) The Committee is authorized to change any bidding conditions & fix the minimum reserve price before bid/ auction.
