In case, a bidder applies for more than one zone, the turnover of the bidder shall be evaluated against sum of the minimum turnover criteria as specified above as applicable for the zone being applied for. In order to qualify for multiple zones, the turnover of the bidder should be at least equal to the sum of the minimum turnover requirement for each of the zone applied for as specified in the table.
