The date of bid submission is from 25.01.2022 at 17.01 Hrs to 07.02.2022 at 12:00 Hrs through e-Tender portal as mentioned above. All bidders are required to get register on e-tendering portal & obtain Digital Signature from NIC office. The technical bid will be opened on 07.02.2022 and the date for opening of the financial bid will be informed lateron.

Online item / percentage rate tenders on prescribed forms are invited from a Company/Firm/Corporation, registered under relevant Act in India who have executed same nature of work as mentioned in eligibility criteria or approved contractors/societies borne on the approved list of appropriate class of contractors/societies in PWD(B&R) Haryana, MES, Railways, CPWD, HUDA, HSAMB, Haryana Warehousing Corporation, HPHC or any other State/Centre Govt. Deptt/Board/Corporation for the above mentioned works and the same will

be opened as per the schedule given above respectively in the office of undersigned in the presence of intending contractors or their authorized representatives, who may choose to attend for the purpose.

Note for intended bidders:

- 1. The tender should be submitted only in online mode.
- 2. The details of documents required in the technical bid are mentioned in the online DNIT.
- 3. DNIT can be seen on any working day during office hours in the office of the undersigned and can be downloaded from our website: https://etenders.hry.nic.in or www.hafed.gov.in
- 4. The Earnest Money shall remain 10% for Civil Contractors and 2% for specialized Roofing contractor of the estimated cost mentioned in DNIT against each work.
- 5. Submission of Earnest money is mandatory as per the category (i.e. roofing contractor/ civil contractor) in which the intended bidder is eligible. The bid will be out rightly rejected in case of non-depositing of earnest money. If any exemption is claimed under any relevant Act / Policy of Haryana Govt. or Central Govt. by the intended bidder, the proof of the same shall be uploaded in the Technical bid.
- 6. The lowest successful bidder has to sign the agreement & deposit performance security in shape of bank guarantee within 7 days of issue of letter of acceptance from HAFED and after that the allotment will be issued to the agency. But in case, if the agency fails to deposit the requisite Bank Guarantee within stipulated time, then the EMD deposited by the agency will be forfeited and the tender will be recalled immediately. Further, the same agency will not be eligible to participate in the re-invited tender.

7. **Performance security**

- A) For successful Roofing Contractor: The successful tenderer will furnish performance security (5% of the contract price) which may be in the form of Bank Guarantee to be kept as a surety that the contractor complete the work satisfactorily. Initially, the performance guarantee will be valid up to end of the defects liability period plus 30 days. In case the time of completion is enlarged, the validity of the guarantee shall be correspondingly extended. It carries no interest and is returned to the contractor after the date specified in the contract.
 - (ii) If the bid of Successful Bidder is below upto **5** % of the estimated cost, the Successful Bidder shall furnish the Performance Security with 1% extra i.e. **6**% of Contractual amount and if the bid of Successful bidder is below more than **5**% of the estimated cost, the Successful bidder shall furnish the Performance Security with **2**% extra i.e. **7** % of the Contractual amount.
- B) For successful Civil Contractor: The successful tenderer will furnish performance security (10% of the contract price) which may be in the form of Bank Guarantee to be kept as a surety that the contractor complete the work satisfactorily. Initially, the performance guarantee will be valid up to end of the defects liability period plus 30 days. In case the time of completion is enlarged, the validity of the guarantee shall be correspondingly extended. It carries no interest and is returned to the contractor after the date specified in the contract.
- 8. All taxes in force or coming into force shall be deducted from the bills of the agency.

- 9. The GST Act as applicable shall be enforced.
- 10. The successful tenderer/ bidder shall ensure that the invoice to be raised with Haryana State Cooperative Supply & Marketing Federation Limited in complain with the provision of the GST law and contains the requisite details in an accurate manner for claiming of tax credits by HAFED. The Corporation reserves the right to release the payment of GST amount only post matching of the invoice in the GSTN system. This shall be ensured by the tenderer/bidder that the invoice raised by him during a month is appropriately reported in the GST returns of the said month. HAFED reserves the right to claim from the tenderers amount of tax, interest, penalty and litigation cost, if any, that may be incurred in future due to now/delay in GST reporting/compliance mistake(s) on part of the service provider.
- 11. GST number of HAFED is 06AAAJH0022R2ZA.
- 12. Conditional tenders will not be entertained and are liable to be rejected.
- 13. In case the day of opening of tenders happens to be a holiday, the date and time of opening of tender will be conveyed later.
- 14. The validity of the tender is 180 days purely at the discretion of HAFED. The contractors who modify their rates, terms and conditions or withdraw within the validity period of tenders, their tenders are liable to be rejected and earnest money will be forfeited."
- 15. Tenderer should have valid GST Registration Certificate from concerned Authorities of the State / Centre as applicable.
- 16. HAFED reserves the right to accept or reject any or all offers without assigning any reason.
- 17. Intending tenderers are advised to carefully study the DNIT/Estimate/ specifications/Building plan etc. which may be seen in the office of the undersigned on any working day.
- 18. Civil contractor should submit proof of valid enlistment/renewal of the enlistment in the online technical bid.
- 19. The roofing contractor shall submit the proof of performance certificate of works(s) of same nature (for which tenders are invited) in the online technical bid.
- 20. Technical bid submitted in any other form or through any other means or to any person/branch of the Corporation shall not be entertained. In case the office feels that such an action has been taken by the contractor for malafide reason, he may be delisted/ debarred from tenders in future.
- 21. Any addition/alteration, if required, will be done as per site requirement at the time of execution.
- 22. The Technical bids shall be opened at 07.02.2022 at 12:30 PM to 05:00 PM in presence of the tenderers or their authorized agent who happen to be present.
- 23. The rates shall be valid for at least 180 days from the date of opening of financial bids.
- 24. The rates should be based on DNIT/HSR 2021 with the ceiling premium as mentioned in the DNIT.
- 25. The rates of Non-Scheduled items mentioned in the DNIT, may be mentioned separately.
- 26. Conditional tenders will be out rightly rejected.
- 27. The Bidder / Contractor should quote their lowest possible rates going carefully through the DNIT. Inclusion of any condition stipulated by a contractor to the effect that his rates

are negotiable or that he is prepared to undertake the job at some percentage less than the lowest rates offered or that he is ready to negotiate further or any other similar condition will render the contractor liable for de-listment/debarment for future tenders.

- 28. The successful bidder will furnish the copy of the bills of roofing material to the Engineer-in-charge as well as to the Division office immediately on the arrival of the material at site. Only after submission of the bills of roofing material & test report of roofing material the bidder will be allowed to start the work at site.
- 29. If at any time after the commencement of the work, the Haryana State Co-operative supply and Marketing Federation Ltd. (HAFED) shall for any reason whatsoever not require the whole work thereof as specified in the tender to be carried out, the Engineer-in-charge shall give notice in writing of the facts to the contractor who shall have no claim to any payment of compensation whatsoever on account of any profit or advantage which he might have derived from the execution of the work in full which he did not derived consequence of the full amount of the work not having been carried out, neither shall have any claim for compensation by reason of any alteration having been made in the original specification, drawing, design and instructions which shall involve any curtailment for the work as originally contemplated.
- 30. The Corporation reserves the right to accept/reject any or all tenders without assigning any reason and the right to call some or all the tenderers for further negotiations, if required.
- 31. **Earnest money**: The earnest money is to be deposited as per below mentioned categories of bidders:
 - A). For Roofing contractor category: The earnest money for roofing category contractor / firm / company / corporation etc. shall remain 2% of the estimated amount. In case of successful bidder the EMD will be treated as part of security deposit. Only those contractor / firm / company / corporation etc. will be considered as roofing contractor who have executed the work of Truss less self supported arch shaped Galvalume sheet roofing with same specification as mentioned in the tender. Any other type of roofing work will not be considered for eligibility as roofing contractor.
 - **B). For Civil Contractor**: The earnest money for civil contractor category shall remain **10%** of the estimated amount. In case of successful bidder the earnest money will be refunded after the submission of performance security in shape of bank guarantee i.e. 10% of contractual value.

Only those contractor / firm / company / corporation etc. who are enlisted with PWD(B&R) Haryana, MES, Railways, CPWD, HUDA, HSAMB, Haryana Warehousing Corporation, HPHC or any other State/Centre Govt. Deptt/Board/Corporation / Govt. Universities in appropriate class will be considered as civil contractor who have executed any civil nature of work as civil contractor.

- 32. **Tender fee**: The payment for tender document fee & E-service fee shall be made by eligible bidders online directly through RTGS/NEFT, OTC & Internet Banking.
- 33. The documents for technical bid shall contains all the requisite documents as mentioned in the Technical bid format/ index for technical bid documents for roofing contractor category and civil contractor category.
- **34. <u>ELIGIBILITY CRITERIA:</u>** For determining the eligibility of Bidder the following shall apply: -

A). For Roofing contractor category:

i) Only those contractor / firm / company / corporation etc. will be considered as roofing contractor who have executed the work of Truss less self supported arch

- shaped Galvalume sheet roofing with same specification as mentioned in the tender. Any other type of roofing work will not be considered for eligibility as roofing contractor.
- ii) The earnest money for roofing category contractor / firm / company / corporation etc. shall remain 2% of the estimated amount. In case of successful bidder the same will be treated as part of security deposit.
- iii) The interested Bidder should have the experience of having successfully completed the work of Truss less self supported arch shaped Galvalume sheet roofing with same specification as mentioned in the tender during the last 7 years ending on 31st March, 2021 and should have work experience as under:
 - a) The bidder should have completed three self supported roofing work (as mentioned above) each costing not less than the amount equal to 25% of total estimated cost in any State Govt. / Central Govt. Board / Corporation of Centre / State.

- i) The interested Civil Contractors shall submit the EMD of 10% of estimated cost. In case of successful bidder the earnest money will be refunded after the submission of performance security in the shape of bank guarantee i.e. 10% of contractual value.
- ii) **Enlistment:** Copy of valid enlistment from MES, Railway or any Central/State Govt. Department/ Board/Corporation / Govt. University or Public-Sector undertaking in appropriate class.

- iii) The interested Bidder should have the experience of having successfully completed any civil work during the last 7 years ending on 31st March, 2021 and should have work experience as under:

- (vi) Affidavit: Affidavit on Non Judicial Stamp Paper duly certified by the Notary stating that the firm (name of the firm) has not been blacklisted / debarred either in Government Departments / Agencies in state of Haryana or Central Government Department / Agencies etc. as on the date of submission of the bid in the present tender (as per Annexure-A). The affidavit shall be of the date from 25.01.2022 to 07.02.2022 and in case the same is not uploaded with the bid then the bid will be rejected outwardly and no claim on this account will be entertained.

The bidder shall submit the supporting documents as above along with Technical bid.

- 35. **FINANCIAL CRITERIA:** The financial eligibility criteria will remain same for both the categories of bidders i.e. **Roofing category** as well as **Civil category**. The criteria is as under:
 - a) The average annual turnover during the last 3 (three) financial years ending on 31st March 2021 should be 1/3rd value of tender estimated cost duly certified by Chartered Accountant. - 39. On allotment of work, the interested Bidders must also submit a warranty certificate for a period of a minimum of 10 years from the original Galvalume Sheet Manufacturer and by the intending Contractor himself.
- 40. The time period to be complete the work shall be as shown in the tender notice.
- 41. The financial bid of only those agencies shall be opened which qualify the technical bid.
