## **CORRIGENDUM - II**

**[2022\_HBC\_210215\_1] Dated 22.03.2022**

On the basis of the examination and analysis of queries received from the prospective bidders, clarifications/modifications have been made in some of the clauses which may be read as under:-

<b>Clause No.</b>	<b>Existing Clause</b>	<b>Proposed clarification/modifications in the clause</b>
Clause 2 Scope of Work	<b>Formulation of DPR:</b> A detailed project report along with Design and detailed engineering works such as Architectural drawings, Structural drawings, Bill of quantities, Cost Estimates, CB Ratio, IRR Calculation, etc. shall be prepared and submitted. Two (2) separate DPRs for Rohtak and Sirsa plant shall be prepared respectively.	Obtaining regulatory permissions is not in the mandate of PMC. It is clarified that preparation of all documentation & completion of all procedural formalities etc. for such assignments e.g building plan, project report for obtaining Pollution NOC etc. will be part of the Scope of PMC. However, the expenditure/fees to be paid to the agencies/ authorities for obtaining regulatory permissions etc. on that account will be borne by HAFED as per actuals.
Clause 4, Eligibility Criteria, Point No. 3	<b>Prior Experience</b> The bidder should have at-least one consulting engagement with Central /State Government or any of its agencies in last <b>three year</b> and should have worked as a <b>PMC</b> for large infrastructure or industrial development projects in the last <b>three years</b> with consulting fee of at least INR 2 Cr.	The bidder should have at-least one consulting engagement with Central /State Government or any of its agencies in last <b>five years</b> and should have worked as a <b>PMC/PMU/PMA</b> for large infrastructure or industrial development projects in the last <b>five years</b> with consulting fee of at least INR 2 Cr. The Consulting fee of at least INR 2 Cr. for single project will be considered.

Clause 7, Evaluation Criteria, Point no. 2.2,	<b>Project Director:</b> Total experience >=15 years Qualification- MBA/PGDM from a reputed college should have experience in chemical and manufacturing sector and working on projects with Government/ Private firms related to undertaking Business Process Studies, Formulating DPRs, benchmarking studies, revenue optimization etc. At-least 3 projects in last 3 years.	<b>Project Director:</b> Total Experience>= 15 years - Qualification-MBA/PGDM/Mechanical Engg. from reputed college (NIRF College ranking up to 150) - Should have experience in Chemical/Manufacturing Sector and working on Projects with Government / Private firms related to understanding Business Process Studies, Formulating DPRs, Benchmarking studies, revenue optimization etc. At-least 3 project in last 3 years: 15 marks – (5 marks for each project).
General Query	Sub-Contracting/ Consortium	As such no sub-contracting/consortium is allowed. However, for the purpose of preparing /working out some specialized works, PMC may obtain services of third parties.
	Team Size/Deployment	Regarding clarification whether experts need to be deputed on client's site on full time basis or they can work from their office.  It is clarified that the bidder is expected to on board the required professionals as per the scope and factor in all the cost accordingly in the financial proposal. However, the PMC will ensure deployment of at least one qualified site- engineer per project for supervision & monitoring of the works at site during execution period of the project.
