1. The bidder must be approved / appropriate Contractor and having HT License from Chief Electrical Inspector to Govt. of Haryana or equivalent i.e. from any other State Govt. Agency.
 2. The bidder should have executed at least one work of 80% of estimated amount OR two works of 50% of estimated amount OR three works of 40% of estimated amount of similar nature. The said work must includes the work of sub-station.
 3. Contractor ID on Haryana Engineering Works Portal is mandatory for interested bidder to participate in tender for technical qualification, otherwise bid not be accepted.
 4. The bidder should upload the Latest Attested Affidavit from Notary (as per Annexure-A) that the agency / contractor has never been blacklisted (the affidavit should be submitted in technical bid).

5. As the work is to be done in Rewari and Narnaul (Haryana), so if any formalities required from any other department of Haryana Govt. like Chief Electrical Inspector or DHBVNL etc, the same may be taken up by the agency at its own level and the cost of the same will be beared by the agency.
