3. Procedure for Procurement / Terms & Conditions of Supply:

1. As per the requirement of Hafed from time to time, the empanelled agency (s) will be asked to submit their rates to Hafed along with the packing & quantity required by Hafed for making purchases of pulses, spices and Ready to Eat items depending upon the requirement. The intimation regarding date of submission of quotation shall be communicated minimum two days in advance.

- 2. The empanelled agencies will provide rate quotation, details including variety of pulses, spices and Ready to Eat items, quantity which the party can supply and quality offered along with the timeline of supply in a sealed envelope.
- 3. Hafed may ask the empanelled party to submit the sample along with rates quoted, which will be intimated by Hafed before-hand.
- 4. The offers submitted by empanelled supplier (s) shall be opened by Purchase Committee and the rates will be compared with market rates and negotiations may be done in case the rates are found to be on higher side. The party will be given supply order the same day or maximum by the next day. Therefore rates quoted shall hold good for a minimum of two days.
- 5. Supply of pulses, spices & ready to eat shall be received on the basis of FOR -Hafed Rice Mill, GT Road, Taraori, District Karnal premises or other destination as specified in particular indent by Hafed.
- 6. All suppliers should meet the requirement of Hafed's specifications (if any) and suppliers will be responsible for any legal action under FSSAI or any other statutory provision arising due to any non-conforming quality of supplies as per these specifications.
- Hafed will endeavor to liquidate the stock in timely manner, however, provision of lifting unsold stock before expiry will be kept after mutual discussion with the party (s) before empanelment.
- 8. Payment: Payment for supply shall be made within 15 days of satisfactory supplies as per terms & conditions of supply order and on receiving documents.
- 9. The detailed quality related and delivery related terms will be mutually discussed and finalized in a transparent manner with win-win situation for both party (s) and Hafed before empanelment.
- 10. The above terms will be discussed with the party before their empanelment and may be revised as per mutual agreement between Hafed & the party.
