Technical bid document will also be submitted online. No other mode of payment shall be acceptable.
- 2. In case Financial bid is submitted but EMD has not been submitted by any bidder, the bid of that bidder will be rejected and the bidder would be debarred from further tendering in Hafed for a period of minimum one year.
- 3. Conditional tenders will not be entertained and are liable to be rejected.
- 4. In case the day of opening of tenders happens to be a holiday, the date and time of opening of tender will be conveyed later.
- 5. The amount of earnest money shall be 1% of the estimated cost in case of Cooperative Labour & Construction Societies.
