INSTRUCTIONS TO BIDDER ON ELECTRONIC TENDERING SYSTEM

These conditions will over-rule the conditions stated in the tender documents, wherever relevant and applicable.

1. Registration of bidders on e-Procurement Portal:

All the bidders intending to participate in the tenders process online are required to get registered on the centralized e-Procurement Portal i.e. <u>https://etenders.hry.nic.in</u> Please visit the website for more details.

2. Obtaining a Digital Certificate:

The Bids submitted online should be encrypted and signed electronically with a Digital Certificate to establish the identity of the bidder bidding online. These Digital certificates are issued by an Approved Certifying Authority, by the Controller of Certifying Authorities, Government of India.

A Digital Certificate is issued upon receipt of mandatory identity (i.e. Applicant's PAN Card) and Address proofs and verification form duly attested by the Bank Manager / Post Master / Gazetted Officer. Only upon the receipt of the required documents, a digital certificate can be issued. For more details please visit the website – https://etenders.hry.nic.in

The bidders may obtain Class-II or III digital signature certificate from any Certifying Authority or Sub-certifying Authority authorized by the Controller of Certifying Authorities or may obtain information and application format and documents required for the issue of digital certificate from.

The bidder must ensure that he/she comply by the online available important guidelines at the portal <u>https://etenders.hrv.nic.in</u> for Digital Signature Certificate (DSC) including the e-Token carrying DSCs.

Bid for a particular tender must be submitted online using the digital certificate (Encryption & Signing), which is used to encrypt and sign the data during the stage of bid preparation. In case, during the process of a particular tender, the user loses his digital certificate (due to virus attack, hardware problem, operating system or any other problem) he will not be able to submit the bid online. Hence, the users are advised **to keep a backup of the certificate** and also keep the copies at safe place under proper security (for its use in case of emergencies).

In case of online tendering, if the digital certificate issued to the authorized user of a firm is used for signing and submitting a bid, itwill be considered equivalent to a noobjection certificate/power of attorney /lawful authorization to that User. The firm has to authorize a specific individual through an authorization certificate signed by all partners to use the digital certificate as per Indian Information Technology Act 2000. Unless the certificates are revoked, it will be assumed to represent adequate authority of the user to bid on behalfof the firm in the department tenders as per Information TechnologyAct 2000. The digital signature of this authorized user will be bindingon the firm. In case of any change in the authorization, it shall be the responsibility of management / partners of the firm to inform the certifying authority about the change and to obtain the digital signatures of the new person / user on behalf of the firm / company. The procedure for application of a digital certificate however will remain the same for the new user.

The same procedure holds true for the authorized users in a private/Public limited company. In this case, the authorizationcertificate will have to be signed by the directors of the company.

(Online Payment Guidelines)

Guideline for Online Payments at e-Procurement Portal of Government of Haryana.

Post registration, bidder shall proceed for bidding by using both his digital certificates (one each for encryption and signing) & Password. Bidder shall proceed to select the event/Tenders he is interested in. On the respective Department's page in the e-Procurement portal, the Bidder would have following options to make payment for tender document fee + Processing fee & EMD:

- A. Debit Card
- B. Net Banking
- C. RTGS/NEFT or Over The Counter (OTC)

Operative Procedures for Bidder Payments

A) Debit Card

The procedure for paying through Debit Card will be as follows:

- (i) Bidder selects Debit Card option in e-Procurement portal.
- (ii) The e-Procurement portal displays the amount and the card charges to be paid by bidder. The portal also displays the total amount to be paid by the bidder.
- (iii) Bidder clicks on "Continue" button.
- (iv) The e-Procurement portal takes the bidder to Debit Card paymentgateway screen.
- (v) Bidder enters card credentials and confirms payment
- (vi) The gateway verifies the credentials and confirms with "successful "or "failure" message, which is confirmed back to e-Procurementportal.
- (vii) The page is automatically routed back to e-Procurement portal
- (viii) The status of the payment is displayed as "successful" in e-Procurementportal.
- (ix) In case of successful payment, a success message along with unique transaction ID is passed on to e-Procurement system. The e- tendering portal shall store the unique transaction number in its database along with the date and timestamp
- (x) The e-Procurement portal allows Bidder to process another payment attempt in case payments are not successful for previous attempt.

B) Net Banking

The procedure for paying through Net Banking will be as follows:

- (i) Bidder selects Net Banking option in e-Procurement portal.
- (ii) The e-Procurement portal displays the amount to be paid by bidder.
- (iii) Bidder clicks on "Continue" button

- (iv) The e-Procurement portal takes the bidder to Net Banking payment gateway screen displaying list of Banks
- (v) Bidder chooses his / her Bank
- (vi) The Net Banking gateway redirects Bidder to the Net Banking page of the selected Bank
- (vii) Bidder enters his account credentials and confirms payment
- (viii) The Bank verifies the credentials and confirms with "successful" or "failure" message to the Net Banking gateway which is confirmedback to e-Procurement portal.
- (ix) The page is automatically routed back to e-Procurement portal
- (x) The status of the payment is displayed as "successful" in e-Procurement portal.
- (xi) In case of successful payment, a success message along with unique transaction ID is passed on to e-Procurement system. The e- Procurement portal shall store the unique transaction number in its database along with the date and timestamp.
- (xii) The e-Procurement portal allows Bidder to process another payment attempt in case payments are not successful for previous attempt.

C) RTGS/ NEFT

This solution shall also allow the bidder to make the EMD payment via RTGS/NEFT this shall add to the convenience of those bidders who are not conversant to use net banking option to make the transaction.

Using this module, bidder would be able to pay from their existing bank account through RTGS/NEFT. This would offer a wide reach for more than 1,10,000 bank branches and would enable the bidder to make the payment from almost any bank branch across India.

- 1. To choose the payment of EMD, the bidder clicks on RTGS/NEFT payment option.
- 2. Upon doing so, the e-Procurement portal will redirect the bidder to apage where it will generate a Challan.
- 3. This Challan shall include the beneficiary (virtual) account number andother details like beneficiary IFSC code each.

RTGS / NEFT Payment Procedure

The bidder shall be required to take a print of the challan and make the RTGS / NEFT on the basis of the virtual account number period on the challan. This provision will ensure that number confidential details regarding the bidder ortender are disclosed to the bank while remitting the RTGS/NEFT.

The bidder would remit the fund at least one day in advance to the last dayand make the payment via RTGS/NEFT to the beneficiary account number as mention in

the challan. SBI Bank shall receive this amount and credit the paymentgateway service provider intermediary Department/PSUs Escrow Security Deposit account post validating the first part of the beneficiary account number, i.e., the client code only, In case of validation of client code is not successful, the bank shall return the fund and not credit the Tec process intermediary Department/PSUs Escrow Security Deposit A/c.

Over the Counter (OTC)

This solution shall allow the bidder having account with SBI bank, to make the payment from any CMS enables Branch of SBI Bank in India. Bidders can make the payment via cash (if amount is <= Rs. 49,999), Demand Draft or SBIBank Cheque.

The procedure for paying through OTC mode is as follows:

- (i) Bidder selects over the counter remittance option in e-Procurement portal.
- (ii) The e-Procurement portal displays the amount to be paid. The bidder chooses the bank account number for refund of the amount.
- (iii) Bidder clicks on "Continue" Button.

- (v) Bidder submits the OTC Challan at the counter of any designated bank of SBI Bank with Cash/Demand Draft/SBI Bank Cheque (Payment in Cash is allowed upto Rs. 49,999/-).
- (vi) SBI bank verifies the URL (format to be discussed and decided) and amount with e- Procurement portal prior to accepting the payment.
- (vii) On successful verification from e-Procurement portal, SBI bank accepts the payment. In case of failure, SBI bank shall return back the OTC challan and payment to the bidder.
- (viii) SBI bank commits the payment transaction (in case of successful verification from e- Procurement portal) and sends the Bank Transaction number (I-Sure Reference Number) online against the URN and Amount.
- (ix) SBI bank will generate receipt for the payment transaction and issues the same to the bidder.
- (x) The e-Procurement system update the bank transaction number against the URN and Amount based on the details sent by SBI bank online prior to generation of the receipt.
- (xi) The status of the payment will be displayed as "verification successful" in e-Procurement Portal, when the bidder clicks on the verification option in the portal.
- (xii) Bidder would be required to upload the scan copy of receipt as received from SBI Bank as part of proof in next tender portal before submitting the tender.

Eligibility Criteria:-

- 1. The specifications of the Rice are as at Annexure-I. It is hereby made clear that any deviation from the prescribed specifications shall not be accepted.
- 2. The Rice will be jointly inspected by the team of HAFED and the IMPORTER of HAFED/ his representative (presently the importer of HAFED is M/s Saleh A Babekar Co., Riyadh).
- 3. The Bidder referred to in this notice, is any real individual or legal entity who wishes to sell Rice.
- 4. Valid GST regulation, PAN No and Bank Account Detail.
- 5. Certification regarding acceptance of all the terms conditions of the tender.
- 6. Bidders will submit the Affidavit regarding none-blacklisted/defaulter by any State/ Central Govt.
- 7. Reputed suppliers / authorized dealers of Rice.

10. EARNEST MONEY AND SECURITY:-

For participations in e-tender, the bidders shall be required to deposit an amount of Rs.50/- per Qtl. as EMD (Earnest Margin Deposit) prior to bidding on which no interest shall be paid by Hafed. However, bidder are advised to deposit EMD well in time at least 3 hours before start of bidding because he will be allowed/enabled to participate in the bidding process only after the EMD deposited by him is confirmed to be received. Earnest money of successful tenders will be adjusted towards security deposit for the satisfactory execution of the order. No interest will be payable on EMD/security deposit. 11. **RATE:**

Only one rate should be quoted for the entire quantity to be delivered. The tenderer will have to quote the rate of 100% of the required quantity of the tendered quantity. The rate offered by bidders shall be F.O.R. at Rice Mill to be intimated by HAFED at the time of delivery, inclusive of GST/all taxes in 50 Kg. net packing in sound bags. Unloading of the material at the Mill will be done by Hafed at its own

cost. Hafed will make payment of net Rice only i.e. exclusive Bardana/Packing material.

12. Negotiations:-

The negotiations will be held as per Govt. Instructions. All the bidders are requested to be present at the time of opening of tender for negotiation.

13. **VALIDITY:**

The offered rates will be valid for 15 days from the date of opening of the tender.

14. **DELIVERY / PENALITY**:

The successful bidder shall be required to complete the supply within 45 days of placing supply order by Hafed. It is hereby made clear that no extension in time period shall be allowed in any circumstances and in case of non supply of the requisite quantity within the time period. Hafed shall be open to purchase the requisite quantity from open market on the risk & cost of the successful bidder.

15. **INSPECTION:-**

The rice will be jointly inspected by the team of HAFED and the IMPORTER of HAFED/ his representative (presently the importer of HAFED is M/s Saleh A Babekar Co., Riyadh). In case, the rice, is not found conforming to the specifications prescribed in the tender document, then the entire consignment will be rejected and the rice will be arranged by HAFED at the risk and cost of the bidder. Any incidental loss incurred by HAFED on this account shall also be recovered from the bidder. The inspection charges to be charged by the IMPORTER/ his representative, will also be borne by the bidder.

Physical inspection of stocks shall be done by the authorized officials of HAFED at the time of receipt in the presence of the supplier or his/ her representative if any. The material will be unloaded only if the authorized officials are satisfied that the quality of the material seems to be of acceptable quality, otherwise the material will be returned back as such at the risk of cost of the supplier. During unloading of the material from each vehicle will be drawn by the authorized officials of Hafed in the presence of the supplier or his/herrepresentative whosoever is present at the time of unloading. For the purpose oftesting, lot wise testing to be done at the time of receipt of rice would beconsidered and one composite sample for each lot would be prepared by mixing the above said samples drawn from each of the vehicle. Out of these four sealed samples, one sealed sample will be handed over to the supplier, onewill be retained by the Rice Mill Taraori and the other two will be sent to the third party inspection agency selected by Hafed for testing. Till the test results are received, the rice will be unloaded/ stored separately. The testing of material from the laboratory would be ensured within 5 working days positively and the final decision regarding acceptance/rejections will be taken on the basis of the test results. Once the material is accepted, it will be stored at a proper placeby the concerned officials of HAFED.

16. PAYMENT/ REFUND OF SECURITY :-

100% payment shall be released within one week of the acceptance of thematerial on the basis of test results and satisfactory completion of total supplies. Security amount/ bank guarantee shall be released /refunded without interest, on satisfactory completion of supplies.

17. **OTHERS:-**

- Hafed reserves the right to hold negotiations with the bidders after opening of the a. financial bids. So, the bidders are requested to remain present at the time of opening of the bids.
